GENERAL COUNCIL MEETING ELECTIONS OF CENTRAL EXECUTIVE COMMITTEE UNIT - MUMBAI METRO CIRCLE

In terms of the power vested to the Core Committee by the Central Executive Committee of the Union, in its meeting held on 12th January 2025, the programme for election of Central Executive Committee members shall be as under:

- 1. Last Date of filing nominations 9th April 2025 up to 5.00 p.m.
- 2. List of valid nominations shall be declared on 11th April 2025 at 5.00 p.m.
- 3. Last date for withdrawal of nominations 19th April 2025 upto 5.00 p.m.
- 4. Final list of candidate(s) shall be declared on 22nd April 2025 at 5.00 p.m.
- 5. Elections at designated booths on 01st May 2025 from 9.00 a.m. to 5.00 p.m.
- 6. Counting of Votes on 03rd May 2025.

All members desiring to contest the elections shall send their Nomination forms / Withdrawal of nomination duly filled, so as to reach us at the below mentioned address on or before the specified dates (the envelope containing the nomination / withdrawal of nomination should be marked on the TOP RIGHT HAND CORNER to read as "NOMINATION FORMS / WITHDRAWAL OF NOMINATIONS")

 - (iii) Ex-Servicemen
 - (iv) SC/ST/OBC employees
 - (v) General Employees
- (C) General Secretary

- 1 Post

- (D) Deputy General Secretary 7 Posts as under:
 - a) 1 for Circle Head Quarter
 - b) 6 One for each module of the Bank and One for Mid-Corp & Corporate Group and One for LHO & LHO Establishments.
- (E) Organising Secretary 1 Post
- (F) Circle Treasurer

- 1 Post

- (G) Deputy Circle Treasurer 1 Post
- (H) Asst. Gen. Secretary 6 Posts One for each module of the Bank and One for Mid-Corp & Corporate Group and One for LHO & LHO Establishments.
- (I) Asstt. Treasurer (Module) 6 Posts One for each module of the Bank and One for Mid-Corp & Corporate Group and One for LHO & LHO Establishments.
- (J) Regional Secretary

One for each administrative region of the Bank in the branch network Five for Mid Corp & Corporate Group Three for LHO & LHO establishments.

(K) Dy. Organising Secretary - 30 Posts as under:

Five posts per module for each module of the Bank.

Five for Mid Corp & Corporate Group

Five for LHO & LHO establishments.

- (i) 1 for General Members
- (ii) 1 for Female Employees
- (iii) 1 for Subordinate Staff
- (iv) 1 for Ex-Servicemen
- (v) 1 for SC / ST/OBC Employees
- (E) Assistant Regional Secretary

One for each group of 15 branches in each district of a region.

Modules designated for the purpose of elections are as under:

(i) South Mumbai

(ii) East Mumbai

(iii) West Mumbai

(iv) Thane

(v) Mid Corporate & Corporate Group

(vi) LHO & LHO Establishments



It may please be noted that for the posts mentioned below members from the area mentioned against them are alone eligible to contest:

- (a) Vice-President (Headquarter) Members working in Mumbai
- (b) Vice-President (Modular) Members working in respective Module
- (c) Dy. General Secretary (Headquarter) Members working in Mumbai
- (d) Deputy General Secretary (Modular) Members working in respective Module
- (e) Circle Treasurer Members working in Mumbai
- (f) Deputy Circle Treasurer Members working in Mumbai
- (g) Asstt. General Secretary Members working in respective module
- (h) Asstt. Treasurer (Modular) Members working in respective Module
- (i) Regional Secretary Members working in branches / offices of respective Region
- (j) Assistant Regional Secretary Members working in branches / offices of respective District / Region.
- (k) If there is more than one module in a city, then any member working in that city can contest for elections for any Modular Post.

For the reserved posts of Vice-Presidents and Deputy Organising Secretaries only the members belonging to the respective categories are eligible to contest.

In case it is found subsequently that the member has falsely filed the nomination without being the member from specified area or specified category, his / her election shall be declared invalid.

Specimen of "Nomination Form" is enclosed herewith. Units may obtain as many photocopies of the form as required by them.

Nomination Form / Withdrawal Form / Voter List is available on union website (www.sbisumc.in).

Members desiring to cast her/his vote should carry any one of the following original documents for the purpose of identification.

Clause no. 15 (d) - Qualification for Election to Central Committee & Office Bearers of the Union

Save as hereunder provided all members of the Union shall be eligible to contest the election of Central Executive Committee members and / or the Office Bearers of the Union.

- (1) The contesting candidate should be the member of the Union at least for a period of one year before the date of election. The Core Committee may however waive the operation of this condition in case of deserving candidates.
- (2) The contesting candidate must have paid her/his subscription and her / his share of donations called for by the Central Executive Committee of the Union, upto date.
- (3) Any member who has been convicted by the competent court for 'Moral Turpitude' shall not be eligible for election to the Core Committee, Central Executive Committee, Working Committee, Delegate and / or Office Bearers of the Unit, provided a period of five years has lapsed since such conviction.
- (4) The contesting candidates must have attained the age of 18 years.
- (5) Any member who has been removed from the Core Committee, Central Executive Committee, Working Committee and / or from the membership of the Union and / or as the member of the Union and / or as the member of the General Council shall not be eligible to contest any elections to any position in the Union for a period of 3 years from the date of her / his such removal. The Core Committee of the Union may however, waive the operation of this condition.
- (6) Any member who has failed to give the account of the Union Funds shall not be eligible to contest the elections of the Office Bearers and Central Executive Committee members. The Union funds shall mean the general funds of the Union and the local unit funds.
- (7) Any member who has wilfully absented himself from participating in any agitational programmes organised by the Union and / or her / his Unit, especially the strike call, shall not be eligible to contest the elections of the Office Bearers and Central Committee members.
- (8) The member disqualified from contesting the elections for Office Bearers and / or Central Executive Committee members shall not be co-opted and / or nominated on Central Executive Committee and / or Regional Committee and / or Unit Committee.
- (9) Any member who has lost the delegate elections and / or the elections of the Central Executive Committee members and / or Office Bearers shall not be eligible for co-option on the Central Executive Committee and/or Unit Committee. However, the Central Executive Committee: may waive the operation of this condition for co-option and / or nomination on Central Executive Committee and the Unit Committee may waive the operation of this condition for co-option on Unit Committee.
- (10) Any member against whom disciplinary action is initiated by the Union and approved by the Core Committee is not eligible contest to election and / or for co-option on any of the Committee.
